Daystar Hosts NTV Town Hall Debate

On Wednesday February 22, 2017, DAC auditorium was filled to capacity as students, faculty and staff from Daystar University, University of Nairobi and representatives of Commission for University Education came together to discuss the state of university education in Kenya.

The Town Hall discussion hosted by NTV anchor Larry Madowo, who is also a Daystar Alumnus was led by a panel of four consisting of Daystar University Vice-chancellor Dr. Timothy Wachira, University of Nairobi Vice-chancellor Prof. Peter Mbithi, the CEO - Commission for University Education, Prof. David Some, and Education Analyst Mr. David Aduda. The issues discussed centered on the recently released Quality Audit of the Universities report, the future of parallel programmes and pre-university programmes, among other things.

On the claim by some media houses that the University of Nairobi and Daystar University are offering fake degrees, Prof Some clarified that it was a false allegation. He went on to express his

disappointment with the credibility of some media outlets saying that he was concerned that the media can deceive Kenyans to that magnitude. "We hope the regulators will come and bail us out," said Prof Some. As he sought to clarify the issue of graduating students early Prof Some explained that some universities like Daystar count the instructional hours as opposed to the calendar year, and as long as the student has covered all the required credit hours, such a student is ready to graduate. Dr. Wachira further explained that some students who have high GPA are able to take more credit hours in a semester; this enabling them to complete their programme earlier. "Quality Audit is necessary for the universities to meet standards set by the Commission for University Education," stressed Dr. Wachira.

"Daystar University was established not only to grant degrees, but we have a commitment first and foremost to God and to the Nation thus, it is unfair to paint us unethical," said Dr. Wachira, as he expressed his disappointment with the media. His concerns were echoed by Sr. Prof A. L. Lando, Senior Lecturer School of

Communication Language and Performing Arts, who called on the media to be responsible and objective in their reporting. "There is confusion today in the country because media misrepresented what was released by the Commission," said Prof Lando, further calling on the media to report what is legitimate and factual. Prof. Some also appealed to the media not to publish or print any content that they are not sure of. On the future of parallel education, Prof. Mbithi assured stakeholders that University of Nairobi would continue to admit qualified people from around the globe.

Education Analyst Mr. David Aduda in his response to the accusation labeled on the media was quick to exonerate Nation Media Group saying that Nation Media Group was not part of those

who reported falsehood. Echoing the earlier speakers he stressed on the need to be factual and having a balanced reporting. "Journalism is not about sensitization of the news; it is about telling the truth. Falsehood smears the entire media fraternity and NTV does not condone such reporting," said Mr. Aduda.

Faculty and students from Daystar and University of Nairobi asked questions regarding higher education and in unison condemned the recent reporting that defamed their universities.

Investigative Journalism Team Shines

Daystar's investigative journalism team has made it to the second round of the ongoing Top Story inter-universities challenge organized by the Africa on Air media consultancy group.

With 20 universities from all over the country participating in the first round at Brackenhurst Hotel in Limuru, the Daystar team with Mary Chumbow, Joseph Nduti and Collins Orono emerged among the 16 teams that made it through to the next round. Eliminated were Laikipia University, Nairobi Institute of Business Studies, Zetech University, and Kenya Methodist University team. The Daystar team begins their next assignment on Tuesday 28th February 2017, at the end of the second round eight teams will be selected for a further round of multi-media engagements.

The top finishing university will walk away with prizes which include: one week sponsored trip to London and visits to BBC and Sky Sports studios.

"The team that will tell the best story among the 16 universities will get a full gear media kit, a one week trip

to London and two months paid internship," Top Story principal Joseph Warungu affirmed.

Prior to elimination day, the 20 universities were required to attend master classes that were taught by media experts from within and outside Kenya. Team members also participated in outdoor activities and ultimately came up with an investigative article which constituted 70 percent of the final mark. The outdoor activities tested team work and cooperation between the different teams and constituted 30 percent of the final mark.

Laikipia University which was among the teams that were eliminated agreed that poor planning and lack of team work reduced their stakes to proceed to the final round. "This has not come as a surprise to us. Lack of coordination and weak team spirit has really contributed to our poor performance," Laikipia University contestant.

The remaining teams will now be put in pairs of two and will be sent to various counties across the country where they will be expected to come up with an investigative story within 24 hours after a thorough investigation.

Shortly after being given the green light to proceed to the next stage, Daystar University team leader Ms. Mary Chumbow confidently confirmed that London was the team's destination. "We are happy for making it through the first round. We are now going to strategize and come up with new techniques that will give us nothing but victory when we return for round two," she said.

The competition aims at producing journalists with diverse skills comparable with world standards. Kindly continue to pray for the team to succeed. For more on this, please read the next issue of Infospot.

Business Incubation Centre Established

Daystar University played host to the 2017 Business Accelerator Finale which was held at The Monarch Hotel, Nairobi on February 18, 2017. This was as a result of an MOU which was signed on 12th January 2017, focusing on incubation of Small and Medium businesses.

After the 10 weeks of coaching by their business mentors, the six founders, who had been selected from over 10,000 projects, were given opportunity to pitch their business ideas to a panel of five judges, for funding and prize money. The panel of judges consisted of our very own Dean School of Business and Economics Mr. Evans Amata, Eric Rosell from Agora enterprises, and Matt Martin.

Speaking at the closing ceremony the Vice-chancellor, Dr. Timothy Wachira, lauded the Venture saying that Daystar endeavors to walk this journey not because there are no other business incubations, but because Daystar wants business incubator that represents Christian principles, because that is what Daystar stands for. He went on to present the awards the three winners.

The first prize went to Prisca Muyodi whose mentor was Mercy Njagi, a Daystar faculty. She took home a cash award of USD 5,000. The first runners-up was EPTF represented by Mary Kamore, Christine Wakesho and Olive Branch, whose team was awarded USD 3,000, while the third prize went to a Daystar MBA student, Christian Butake, who pocketed USD 2,000.

Dr. Samuel Muriithi, Senior Lecturer Daystar University spoke on the importance of culture and communication in the incubation of a new business. "Kingdom business honors God, it is business done with character, has integrity and is practiced with honesty," he said. He went on to give characteristics of Kingdom business which are:

1. Understanding God's purpose - Chronicles 29:11
2. Innovativeness and creativity – Deuteronomy 28:13
3. Mark of excellence – Ecclesiastes 2:10
4. Good stewardship



activity was visiting one of the students supported by this initiative in Kitale namely, Mr. Ezekiel Chebunde.






Corporate Governance in Africa: Assessing Implementation and Ethical Perspectives 1st ed. 2016



Transport Notice To and From Athi River Campus

To Athi River campus students:
